ENVIRONMENTAL COMPLIANCE CERTIFICATE

DENR-NCR hereby grants Environmental Compliance Certificate (ECC) for the Metal Fabrication and Lamp Shade Manufacturing Plant of ATLANTIC MANUFACTURING CO., INC. located in a 10,000.0 square meters parcel of land at 410 - 412 Service Road North Expressway Canumay, Valenzuela City after complying with the Environmental Impact Statement (EIS) System requirements as prescribed in the guidelines of the Implementing Rules and Regulations of Presidential Decree No. 1586.

This Certificate is issued subject to the following conditions:

 That this certificate covers the Metal Fabrication and Lamp Manufacturing Plant with the following production capacity:

Product	Production Capacity
Metal Plates	50 MT/month
Street Light Post, 10-40 ft long	10 pcs/day
Acrylic Plastic Lamps	25 kgs/day

Any modification from the approved project scope shall be officially relayed to this Office for its information, evaluation and approval;

- 2. That all the proposed mitigation measures contained in the Project Description shall be effected;
- 3. That should adverse impacts occur as a result of project operations, all the activities causing the same shall be temporarily stopped until such time that remedial measures have been effected and inform this Office within the day through any means of communications;
- 4. That in case of abandonment, the project proponent shall inform this Office thirty (30) days before abandonment and provide safety protective measures for protection purposes and to prevent adverse environmental impacts;
- That the project proponent shall allow EMB-NCR personnel with proper identification card and travel order to conduct inspection/monitoring in the entire premises without prior notice to oversee compliance to ECC conditions;
- That the transfer of ownership and/or change of name of the project carries the same conditions in this ECC for which written agreement shall be made, copy furnish this Office of the said document for record purposes;
- 7. That this Certificate shall be posted in a conspicuous place in the Administration's Office for easy reference and guidance;

 That a written notification shall be made to the DENR-NCR for approval in case the project proponent cannot comply with any of the conditions for technical reasons.

Non-compliance with any of the above stipulations and/or misrepresentations in the IEE submitted by the proponent will be sufficient cause for the suspension or cancellation of this Certificate and/or imposition of a fine in an amount not to exceed **Fifty Thousand Pesos (P50,000.00) for every violation** thereof pursuant to Article IX, Section 6.0, DENR Administrative Order No. 37, Series of 1996. This ECC is not a permit rather it is a certification that the proponent has committed to undertake or implement mitigative measures to reduce the negative environmental impacts to acceptable level.
